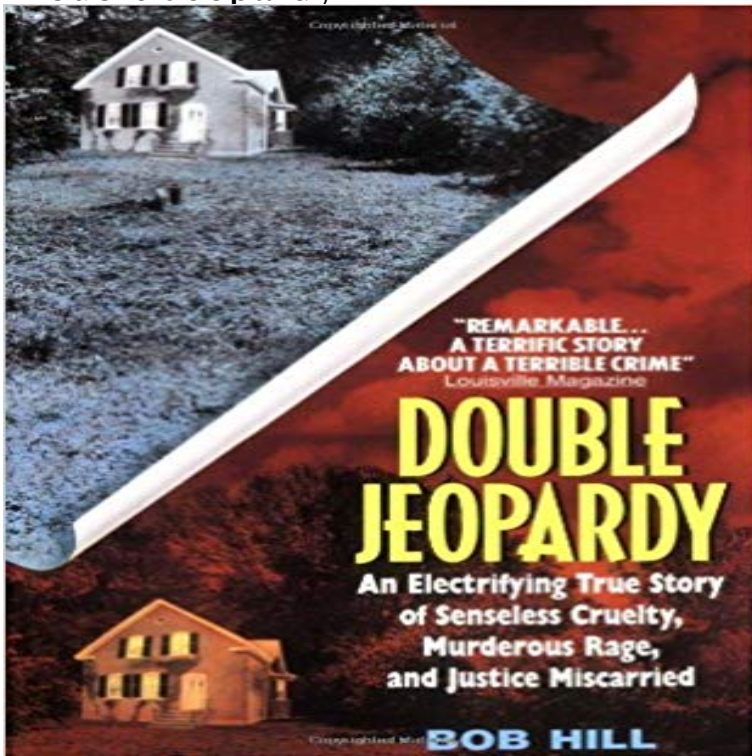


Double Jeopardy



In America, it is illegal to prosecute a person for the same crime, no matter what the circumstances. It is a law intended to protect the innocent from unfair harassment and persecution.
