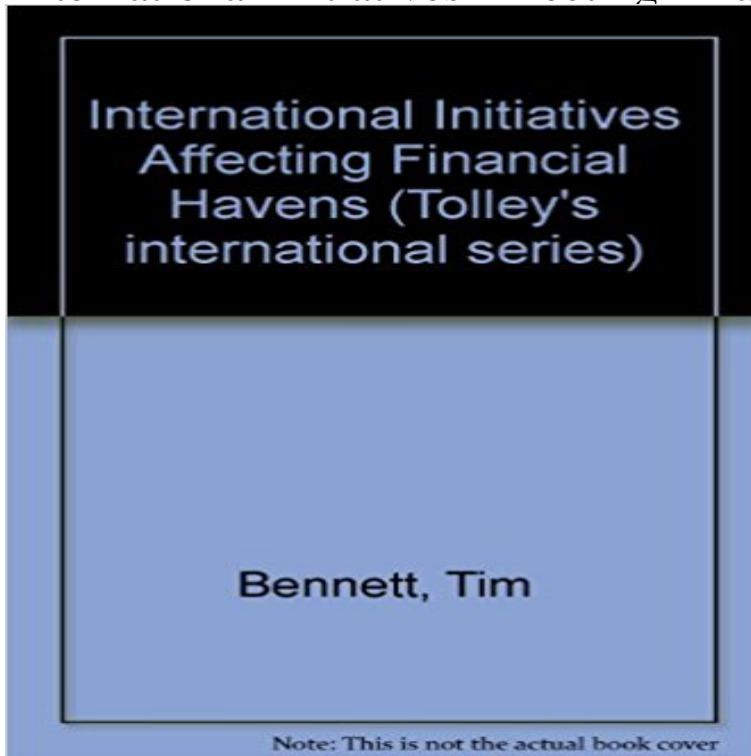


## International Initiatives Affecting Financial Havens
