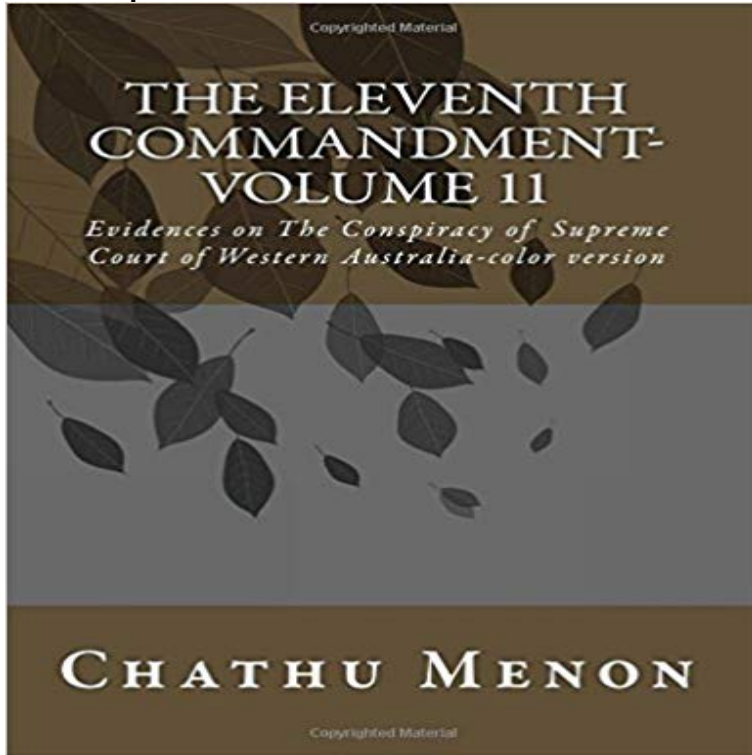


## The Eleventh Commandment-Volume 11: Evidences on The Conspiracy of Supreme Court of Western Australia-color version
