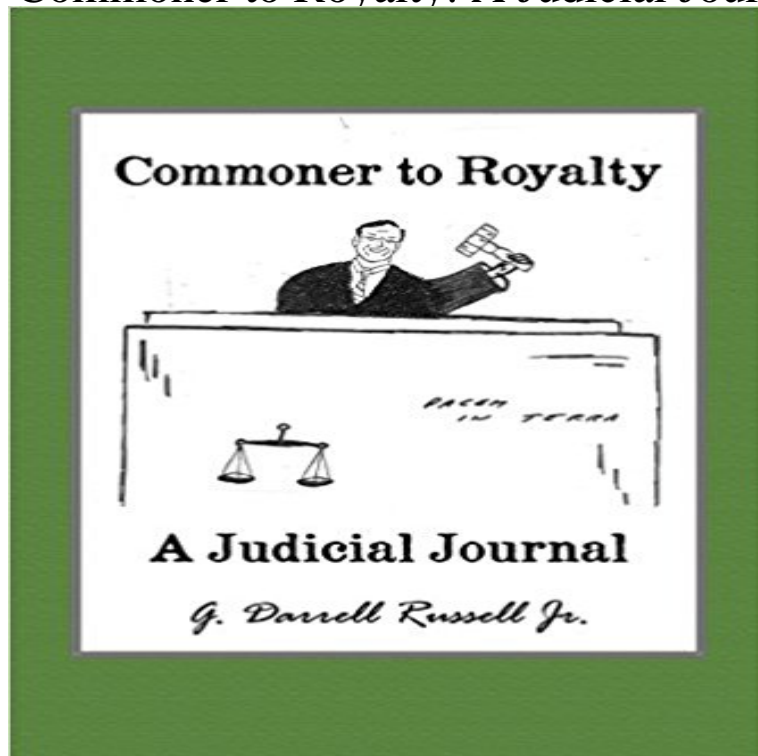


## Commoner to Royalty: A Judicial Journal
