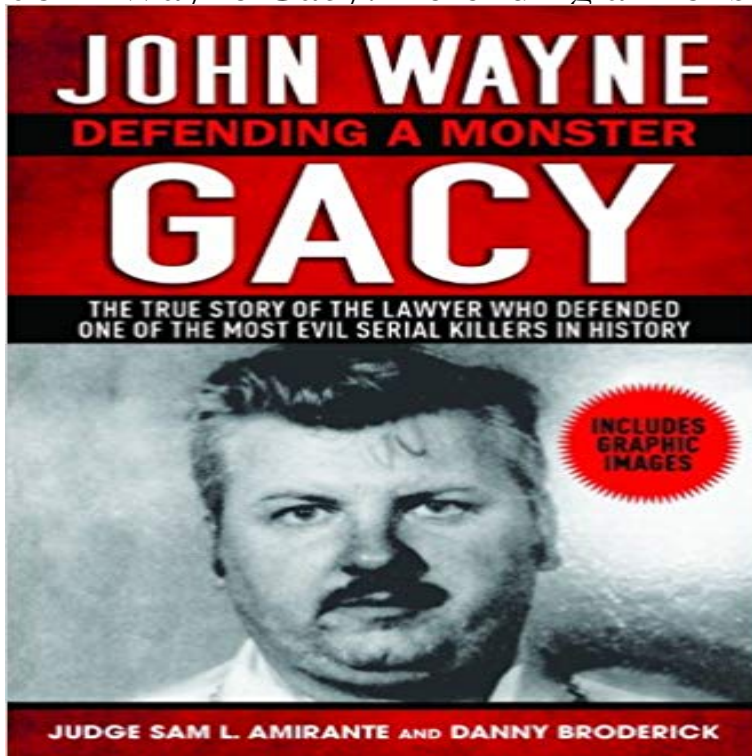


John Wayne Gacy: Defending a Monster
