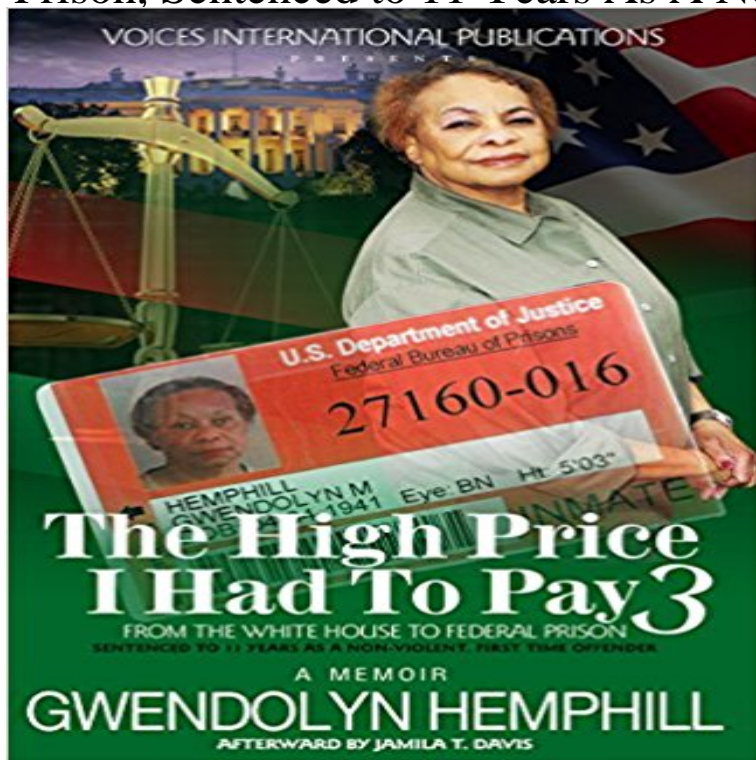


## The High Price I Had To Pay 3: From The White House To Federal Prison, Sentenced to 11 Years As A Non-Violent Offender
