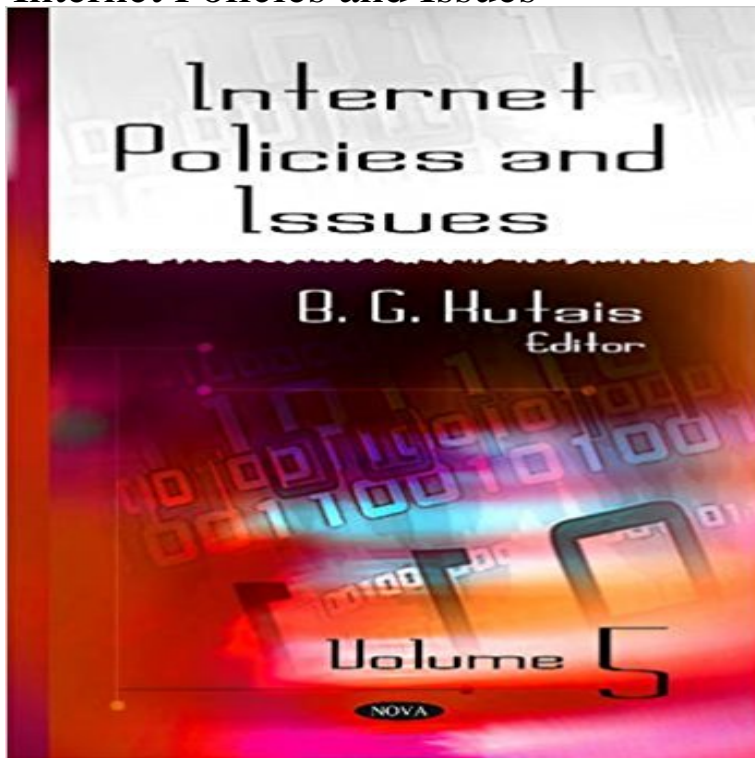


## Internet Policies and Issues
