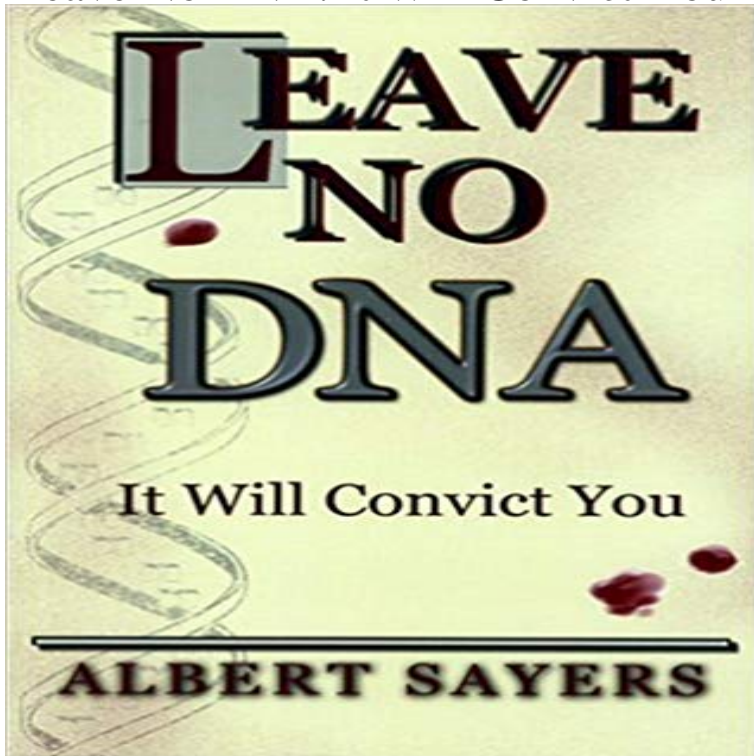


Leave No DNA: It Will Convict You
