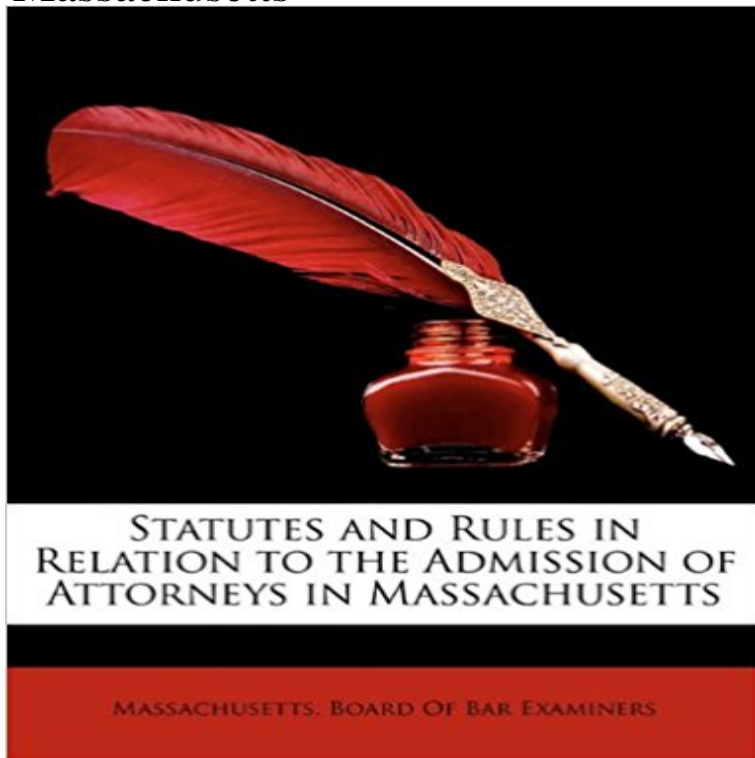


Statutes and Rules in Relation to the Admission of Attorneys in Massachusetts
