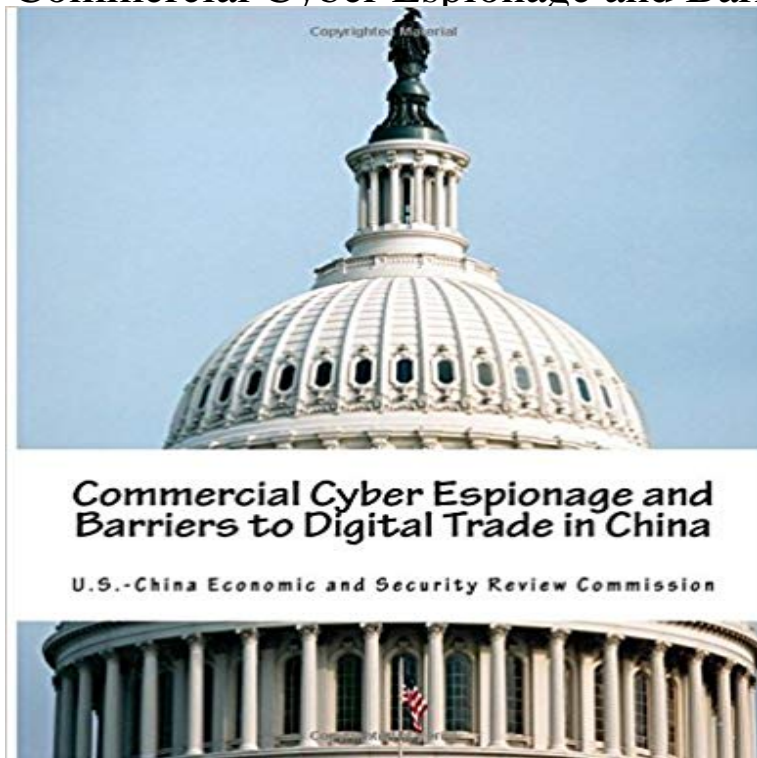


# Commercial Cyber Espionage and Barriers to Digital Trade in China



This hearing will examine Chinas use of standards, regulation, and censorship as a market-entry barrier.
