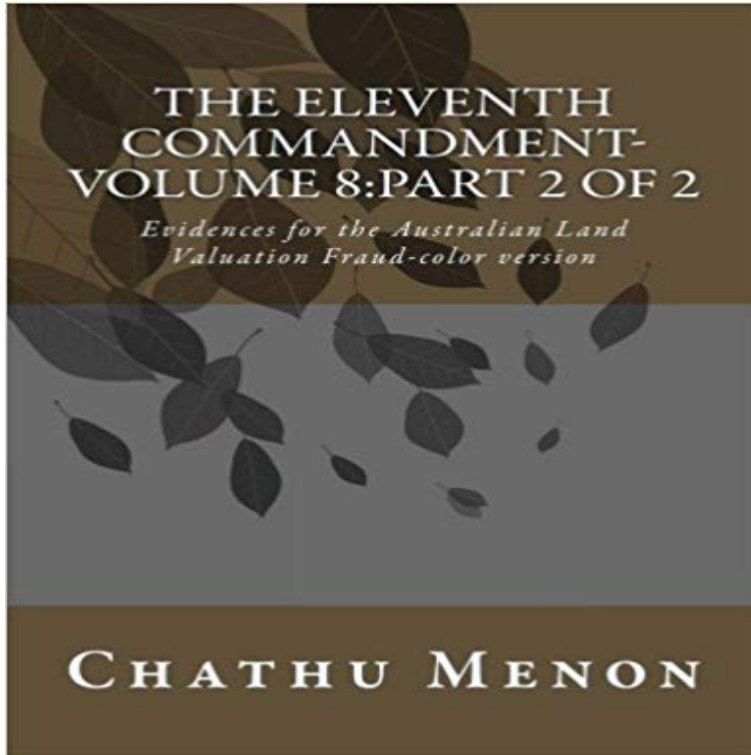


The Eleventh Commandment-Volume 8:Part 2 of 2: Evidences for the Australian Land Valuation Fraud-color version
