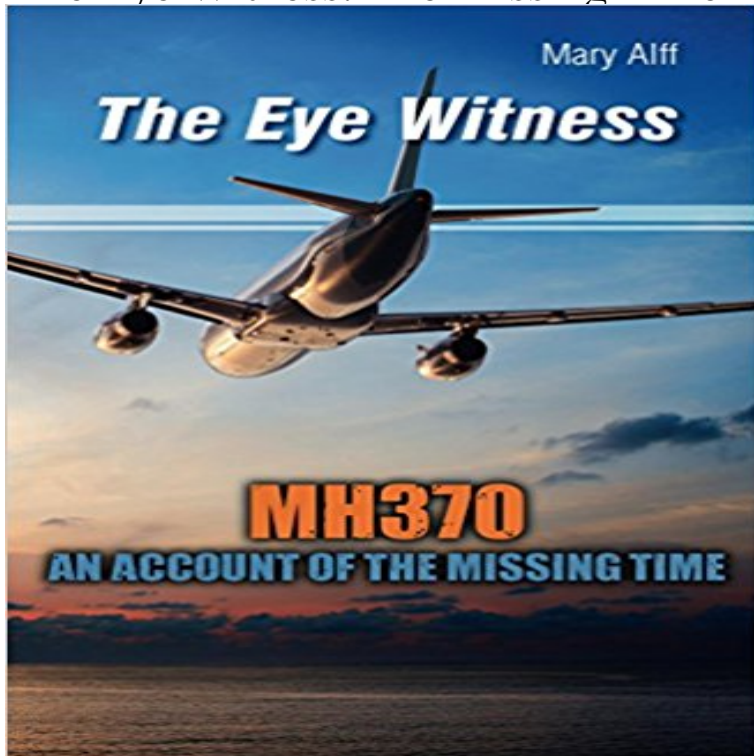


The Eye Witness: The Missing Time

Sadly, she did not have the likelihood to be interviewed by any great Media, but she says modestly, she doesnt need such honors and it really doesnt matter. She has no doubt in her mind that what she has to say will shock many who hear it. She believes this may encourage many more people to come out and reveal what really happened to Malaysian MH370, and what happened on the ground, on the morning it disappeared and days following. She urges those with influence to demand for the Tower-Pilot communication Audiotapes. She is convinced that there is more than meets the eye, right there. Like everyone else on the globe, she has waited long and patiently for the recovery of the plane which everyone in the search seems sure ... ended in the Indian Ocean. We have watched searches in the wrong stretches of water and with each new dawning day, it becomes clear, theres need, not to find the plane. This book reveals why. She has taken the first step in revealing what happened inside the plane above the seas, and hopes many more will follow in her path. She wants everyone to know that the disappearance of Malaysian MH370 is no mystery at all, and it has never been. It is time for the truth to be told. She is telling everyone who gets on a plane for whatever reason, to feel the pain of the families in Malaysia and China and those others we never got to know about. This incident has happened to everybody, and for this reason, it is everyones business to get involved in asking how they can get this matter off the hands of those covering up what smells like crime, and give it to those who will do the right thing. Mrs Wolff, who still believes in the goodness of the human race, says she knows this is possible. She agrees it may take longer than anticipated, but it will be finally established.
